

## **Natunola Health Biosciences Inc.: Corporate Press Release**

### **Natunola Releases Third Quarter 2008 Results**

Winchester, ONTARIO--(November 7, 2008)

Natunola Health Biosciences Inc. (TSX-V:NHI) ("Natunola") (formerly Sentex Systems Ltd.) reports that the revenue for the quarter ended on September 30, 2008 was \$475,058 as compared to \$583,217 for the comparative period for 2007 with a decrease of \$108,159. The decrease is due to lower sales. As a result, the Company had a net loss of \$97,670 or \$0.00 per share for the quarter ended on September 30, 2008 as compared to a net profit of \$4,215 or \$0.00 per share for the comparative period for 2007.

The lower sales are due to the decrease in sales of the Company's cosmetic and personal care products by \$72,250 or 50% for the quarter ended September 30, 2008 versus the comparative period for 2007. The decrease is due to fewer shipments of the Company cosmetic and personal care products in the US market.

The sales of the Company's flax products continued to grow and increased by \$51,506 or 15.2% for the quarter ended September 30, 2008 versus the comparative period for 2007.

General expenses declined by \$102,019 or 9.8% for the nine months ended September 30, 2008 versus the comparative period for 2007. The decrease is due to lower general and administrative costs.

Gross margin percentage decreased by 5.1% for the nine months ended September 30, 2008 versus comparative period for 2007. The decrease in gross margin percentage is due increasing fuel cost and higher commodity costs.

The sales of the Company's flax products increased by \$402,499 or 40.2% for the nine months ended September 30, 2008 versus the comparative period for 2007. The sales of the Company's cosmetic and personal care products decreased by 40.7% for the nine months ended September 30, 2008 versus the comparative period for 2007. As a result of these, the Company recorded a net loss of \$2,381 or \$0.00 per share for the nine months ended September 30, 2008 as compared to a net profit of \$2,136 or \$0.00 per share for the comparative period for 2007.
